Membership

Membership of the SA Legion – UK and Europe will comprise of 3 levels: Ordinary Membership, Associate Membership and Honorary Membership.

Ordinary Membership

- 1. All persons who have rendered at least six months' service in, with or as part of any of the military and security forces of:
 - a. The Union of South Africa.
 - b. The British Armed Forces (Her Majesty's Armed Forces).
 - c. The Republic of South Africa.
 - d. Member Nations of the Commonwealth.
 - e. The former self-governing territories known as the TBVC states.
 - f. The South West Africa Territory (prior to implementation of UN Resolution 435).
- 2. The qualifying criteria will be the presentation of Force or Service Number and/or proof of service to the SA Legion UK and Europe Committee
- 3. All persons who rendered at least six months' service with non-statutory South African military formations prior to 1994 and can furnish a service number and/or proof of service.
- 4. All persons who were prevented from rendering further service by reason of ill health, wounds, disease and physical or mental disabilities sustained while engaged on service.
- 5. All persons in Armed Forces allied to the United Kingdom or South Africa.
- 6. All persons whom the SA Legion in the UK Branch Executive in their sole and absolute discretion consider to be fit and suitable candidates for membership.

Associate Membership

- 1. Members of the Royal British Legion.
- 2. Persons who have an association with any of the above mentioned services and who would support the aims and goals of the SA Legion UK and Europe
- 3. Members who are not eligible for Ordinary Membership (i.e. non-service members)
- 4. Any Adult person can be granted Associate Membership status by the SA Legion UK and EU Executive.

Honorary Members

- 1. Honorary Membership will be extended by the SA Legion UK and Europe Executive to persons deemed worthy of such membership.
- 2. Honorary members will be required to submit relevant membership application forms.
- 3. Honorary members will not be extended voting rights but may be invited or co-opted to serve on the committee or other working Groups by the SA Legion Executive.

The SA Legion - UK and Europe Executive may at its SOLE discretion decline to grant any membership, without prejudice for any reason whatsoever.

By signing this application the applicant confirms that the information provided is true and without alteration, agrees to comply with the letter and spirit of the constitution, bylaws and rules of conduct of the SA Legion and Royal British Legion.
